DEMANDS AS FAR AS POWER IS CONCERNED, AND THE LOCAL ELECTRICITY BOARD HERE IS VERY SHORT OF PUROS FOR OTHER PROJECTS AND THE CONSUMERS ARE SUFFERING IN A NUMBER OF MAYS, INCLUDING INCHEASED TARIFFS. IT IS FELT THE COMMONWEALTH SHOULD COME TO THE AID OF THE BOARD, AFTER ALL, THE COMMONWEALTH WILL SENEFIT 45 MUCH AS THE STATE.

OVER THE YEARS THERE HAS BEEN A COCO DEAL OF DISCUSSION ON FINANCIAL RESCURCES OF LOCAL A D STATE COVERNMENTS. II HAS BEEN SUGGESTED BY SOME OF THE LOCAL GOVERNING BODIES THAT THERE SHI UID BE A COMMONABALTH INVESTIGATION OF THESE REQUIREMENTS AND THE LINE AS HAVE TAKEN IN THAT AS WOULD BE PREFARED TO JOIN SITE THE STATE COVERNMENT AND LOCAL GOVERNMENT IN MAKING SUCH AN EMULIBY, BUT SO FAR THAT PROPOSAL HAS BEEN RESISTED BY THE STATE COVERNMENT. THE STATE GOVERNMENT IN TURN LOCKS TO THE COMMONREALTH GOVERNMENT AND I CAN GIVE YOU SOME IDEA IN THE MAY OUR PROVISION FOR STATE FURFOSES HAS EXPANDED OVER RECENT YEARS. AND IF I COMPARE THIS AITH THE LAST PURIOD OF OFFICE OF THE LARKUR PARTY IN 1949/30 ALTOGETHER PAYMENTS TO THE STATE INCLUDING FINANCIAL ASSISTANCE GRANTS, AID FOR ROADS, ALLOCATION OF LOAN PAYMENTS FOR HOUSING, RORKS AND HOUSING BORROWING (THIS IS A SEPARATE ITEM) THE TOTAL PAYMENTS FOR THE STATES BY THE COMMONNEALTH MAS \$202.000.000 AT THAT TIME, AND IN OUR LAST BUDGET AR ESTIMATED THE TOTAL PROVISION HAS ONE THOUSAND THO HUNDRED AND THIRTY FOUR MILLION DOLLARS WHICH IS JUST OVER SIX TIMES THE TOTAL OF 1949/30. (R) WARALLY THEN YOU HAVE NOT ONLY THE PREVISION OF THE STATE GOVERNMENT TO BIKE OUT OF THEIR RESOURCES BUT THE SEMI-GOVERNMENTAL PROGRAMME AE WOFK OUT WITH THE STATE OF THE TOGETHER RECORD AS A REALONABLE PROCERUME OF BORROWING POR SEMI-GOVERNMENT FURPOSES, AND THAT IS THEN ALLOCATED UNDER THE FORMULA OR BASIS ON SHIGH THEY AGREE AT THE LOAN COUNCIL MEETING AMONGST THE LITATES. NOW THAT IS MICKE MATTERS STAND AT THE PRESENT TIME.
